

TERMS AND CONDITIONS

FOR UNIVERSITY USERS REGISTERING ON THE CAREER OFFICE APPOINTMENT BOOKING WEBSITE

These Terms and Conditions (hereinafter referred to as "Terms") govern the use of the website www.idopontfoglalas.karrieriroda.pte.hu (hereinafter referred to as "Website") operated by the Career Office of the Rector's Cabinet, Educational Directorate of the University of Pécs (PTE RK OIG KI) (hereinafter referred to as "Service Provider"). By registering on the Website and using the registration system, you agree to these Terms. These Terms are effective from January 23, 2023, and remain in force until revoked or until modifications take effect.

These Terms comply with Hungarian law, particularly Act V of 2013 on the Civil Code, the Regulation (EU) 2016/679 of the European Parliament and Council (General Data Protection Regulation), and Act CXII of 2011 on Informational Self-Determination and Freedom of Information. The mandatory provisions of the applicable laws apply to the parties without any specific stipulation. These Terms apply to any legal obligations arising between the Parties, even without specific and explicit provisions.

1. BASIC PROVISIONS

The website www.idopontfoglalas.karrieriroda.pte.hu is a portal operated by the University of Pécs, enabling university users to access information about free programs organized by the PTE RK OIG KI, such as various competency development workshops, training sessions, lectures, and individual consultations. After registration, users can access the booking system necessary for signing up for these programs.

2. USERS OF THE SERVICE, DATA PROCESSING, DATA SECURITY

The Website continuously provides information about data processing practices related to its use. The data controller outlines the rules for handling personal data (e.g., what personal data is processed, the purpose of processing, and the rights of the data subjects).

UNIVERSITY USERS

University users who wish to use the services must provide the required information on the registration form, including name, EHA/Neptun code, email address, phone number, faculty, major, level of education, and legal status. These data will be processed according to the privacy policy.

The services offered by the Service Provider (lectures, training/workshops, consultations) are available exclusively to university users after registration.

3. CONDITIONS OF REGISTRATION AND PURPOSE OF THE WEBSITE

By registering on the Service Provider's appointment booking website, PTE RK OIG KI, users agree to the terms of registration and undertake to comply with the provisions set out in these Terms.

Only university users who are current or former students of the University of Pécs, or employees of the University, are eligible to register on the Website.

Registration allows users to subscribe to the PTE RK OIG KI Newsletter and use the appointment booking system, through which they can sign up for PTE RK OIG KI programs (lectures/training/workshops/consultations).

4. COMMUNICATION, SUSPENSION, TERMINATION OF SERVICE

5. SERVICE-RELATED PROVISIONS

Upon registration on the Website, the Service Provider offers the following services to university users:

University users can sign up for individual or group programs announced by the Service Provider through the booking system.

After registration, university users who subscribe to the newsletter will receive a monthly newsletter at the email address provided during registration, informing them about current programs organized by the KI and job and internship postings by employers.
